2024 brought Safe House Project new launches of training curriculums, incredible opportunities to engage new partners in education, and the acquisition of Anti-Trafficking International (ATI). The progress made this year through training initiatives transformed opportunities for survivors right before our eyes as we walked alongside survivors recognizing and believing for the first time that freedom and healing are possible.

TRAINING INDIVIDUALS TRANSFORMING COMMUNITIES

At Safe House Project, we have witnessed firsthand the transformative power of education to turn the tide against human trafficking and bring tangible hope into the lives of survivors. Empowering communities across the U.S. to recognize, report, and prevent exploitation does not simply raise awareness about trafficking hiding in our communities – it is a catalyst for change that shines light into the shadows and illuminates a path toward freedom and healing for every survivor.

Cultivating comprehensive training options for key members of our communities drives collaboration and deeper partnerships on a local level, revolutionizing their ability to advocate for action on behalf of the survivors they encounter personally. By empowering individuals to respond effectively, Safe House Project is transforming the ability of our communities, our states, and our nation to address the crisis of human trafficking.



OnWatch is a survivor-led training designed to empower community members to spot, report, and prevent sex trafficking in their daily lives. Through real survivor stories and expert insights, participants learn to identify key indicators of trafficking and how they can be the difference in a survivor's path to freedom.



God's Heart to Eradicate Trafficking equips faith communities to take action against human trafficking and support survivors throughout their healing journeys. This training mobilizes the Church to serve the least of these, love our neighbors, and seek justice in an unjust world.



The H.O.P.E. Training (Healthcare Observations for the Prevention & Eradication of Human Trafficking) is a survivor-informed, trauma-informed, and patient-centered video-based training that equips all healthcare workers to identify potential human trafficking victims, give support, and offer resources.



Every day, in-home service providers visit millions of homes and business. Developed in partnership with Cetane, this training course equips them to spot, report, and prevent trafficking in their daily work, empowering a volunteer network to be part of the solution in combatting human trafficking cross the United States.



ANNOUNCING THE ACQUISITION OF ANTI-TRAFFICKING INTERNATIONAL

Safe House Project is proud to announce the acquisition of Anti-Trafficking International (ATI).

A trusted and prominent leader in human trafficking prevention, education, and advocacy, ATI has empowered communities and individuals alike to take action against human trafficking since 2013. Addressing the root causes of exploitation and teaching community members to recognize, report, and prevent human trafficking is a hallmark of ATI's impact over the last decade. In 2024 alone, ATI tripled their community outreach efforts, leading to a significant increase in awareness of trafficking and requests for prevention training in schools, social service organizations, and corporations across the United States.

As Safe House Project integrates ATI's *Just Ask Curriculum* with our own training courses and survivor-focused programs, communities across the United States will gain comprehensive access to education that both prevents exploitation and equips individuals to respond effectively when it occurs. The team at SHP and ATI look forward to amplifying our combined expertise to equip more communities to unite around our vision to see human trafficking eradicated and hope, freedom, and a future restored to every survivor.

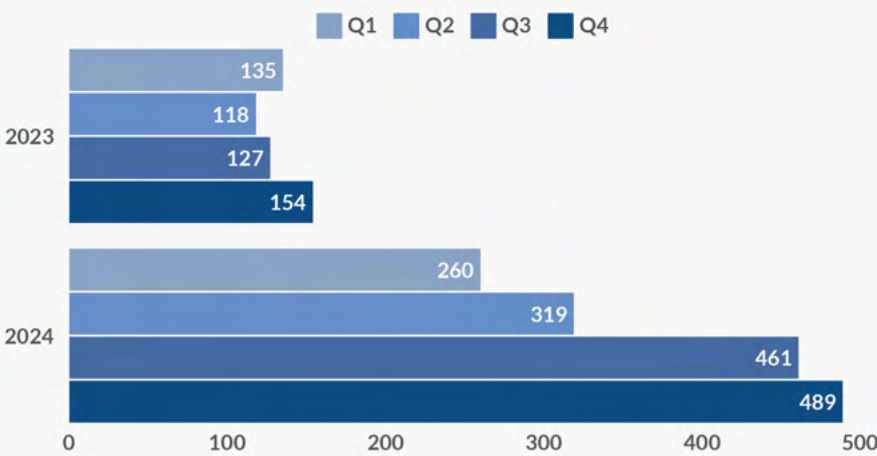

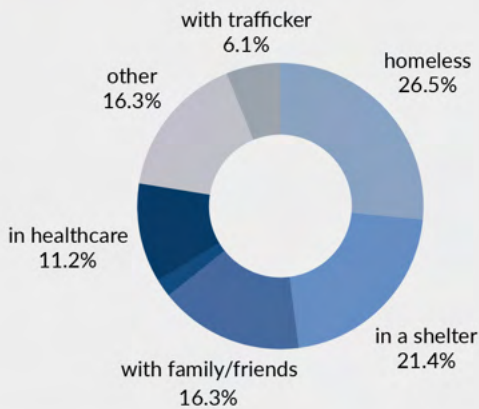

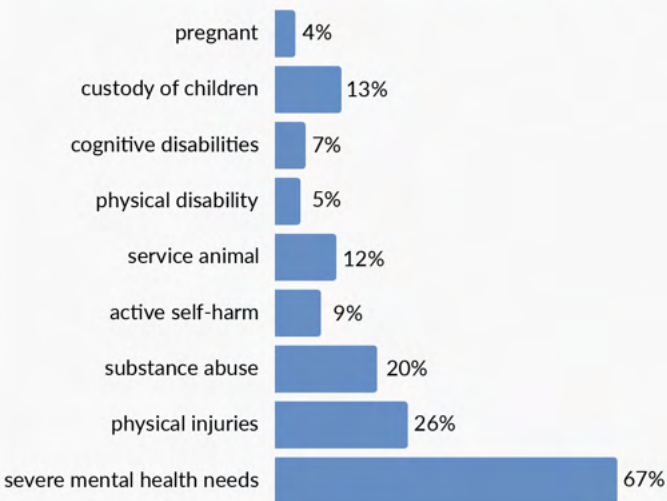

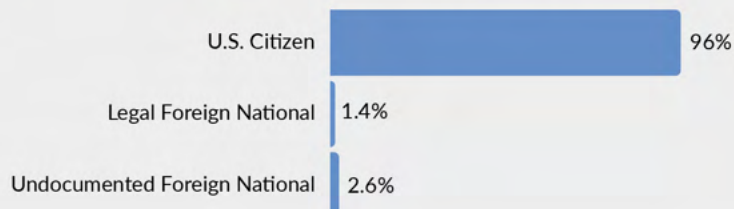

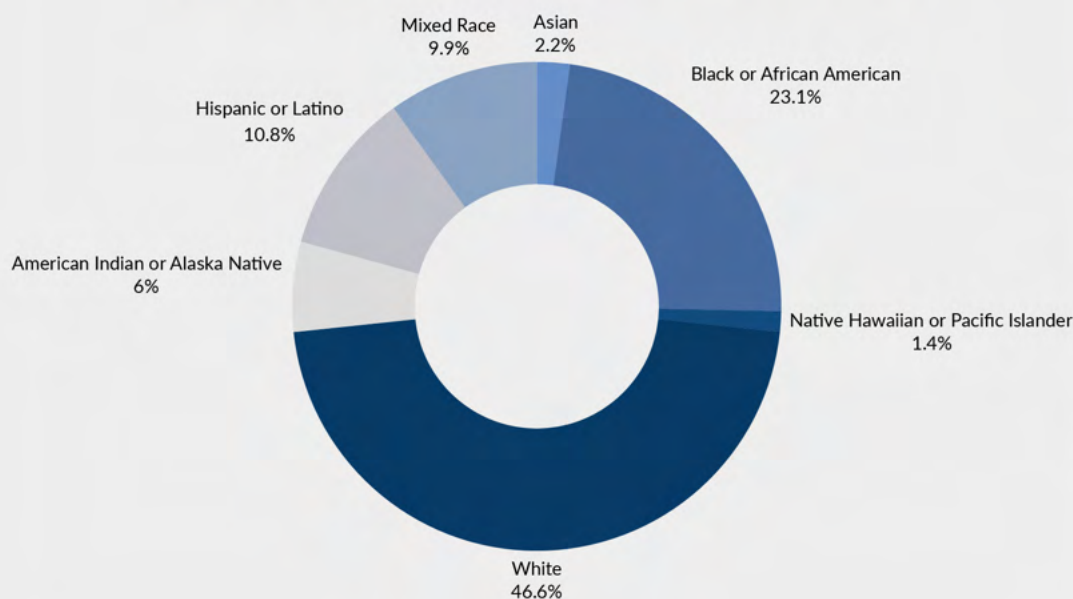

STORIES OF FREEDOM

I have experienced so many “firsts” in this safe house program that will always stay with me. Watching the solar eclipse with all the staff and other residents, seeing the Northern Lights for the first time, learning how to cook and sew, breathing fresh air every day, living in a safe, serene, and tranquil environment, making friends who understand where I come from, the amazing unconditional love and support that I receive every day, sleeping in a bed where I have never been hurt, safe hugs and touches, and so many more.

At times, I fight against the staff and all the good they are trying to do – I’m just not used to being cared for like this. While this journey has been enormously difficult, it has also been beyond anything that I could have ever imagined. I can’t thank SHP enough for this chance.

I have been in this program for three months already, and I can’t believe how quickly the time has flown by. It has been so beneficial for my recovery to be in a bubble, protected and safe from the outside world. I can’t believe how much I have grown in this short amount of time. I still have to occasionally pinch myself to make sure that such a place like this really does exist. Thank you for helping me get here and for helping me become who God created me to be. Thank you for helping to change my life for the better.

OLIVIA, SURVIVOR

Madison first called from the hospital emergency room after being beaten by a regular client. Her trafficker had taken full advantage of her mental illness and addiction, forcing her to return to this client because he paid well. She had tried to leave before, but never made it far enough away.

Over the next year, Madison moved between shelters and living with her trafficker, trapped in a cycle of uncertainty and fear. We lost touch several times, but always kept looking for her. Eventually, a family that drove past her on the street regularly brought her to a hotel and bought her some food, and she remembered Safe House Project’s number. We found her a safe house program able to provide the level of mental health care and addiction support that she needed, and she agreed to give it a chance.

Now six months later, the program director describes Madison as a role model to the other residents, helping them get involved in all the activities and therapy the program offers. She is an excellent writer and hopes to become a published author one day.

Madison’s story is the reason that we don’t give up. Every staff member on the Survivor Support Team has been a part of helping her reach this point of healing, and it took all of our experience and the kindness of strangers to eventually give her the courage to try again.

Madison inspires us to continue answering the phone every day. Even when the road to freedom is long, there is hope for healing on the other side, and every survivor deserves that opportunity.

SAFE HOUSE CERTIFICATION

Safe House Certification is a critical element in ensuring that trafficking survivors receive high-quality, trauma-informed care in safe, supportive environments that prioritize their healing and independence. By establishing rigorous, evidence-based standards, this program promotes accountability throughout the anti-trafficking field, as well as excellence and collaboration among service providers.

In 2024, Safe House Project and the Certification Review Board implemented refined certification standards, leading the charge toward more comprehensive and more effective post-exploitation care for survivors. As our network of certified partners grew throughout this year, our team placed survivors in crisis with greater confidence and efficiency, knowing that these partners serve survivors with high-quality care and compassion.

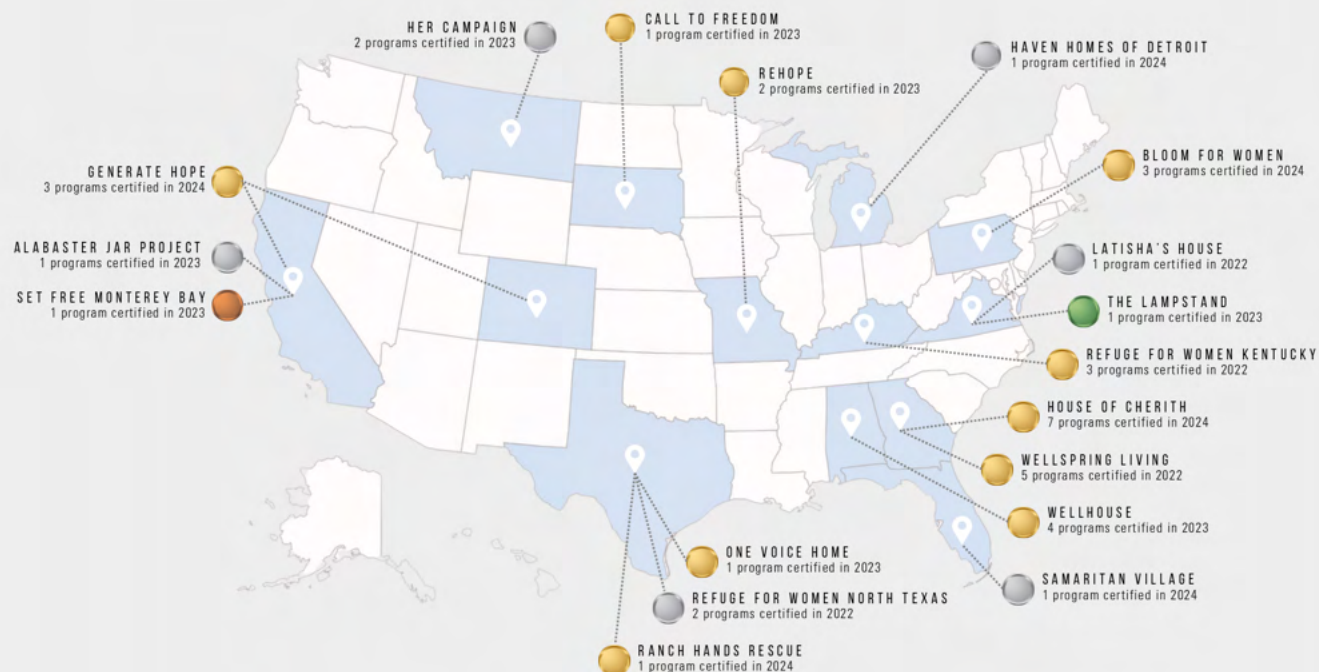

SAFE HOUSE CAPACITY BUILDING

Partnering with safe house programs across the United States is key to Safe House Project's mission to ensure that every survivor has access to holistic care after exploitation. Through our capacity building partnerships, we enhance the capacity of restorative care programs to serve survivors and eliminate obstacles that hinder their access to aftercare. In 2024, we focused on expanding housing capacity, stabilizing staffing needs, and prioritizing specialized services and training to ensure comprehensive support for survivors.

TRAFFICKING SURVIVOR EQUITY COALITION

The Trafficking Survivors Equity Coalition (TSEC) continues to drive impactful policy advocacy, addressing critical gaps in anti-trafficking legislation and ensuring survivors receive the resources they need to rebuild their lives. Through coalition-building, strategic partnerships, and dedicated advocacy efforts, TSEC has achieved significant milestones this year.

TSEC MEMBER ENGAGEMENT

Legislation Supported:

TSEC advocated for eight critical bills at the federal and state levels in 2024.

Stakeholders Engaged:

TSEC reached over 200 coalition members, including policy makers, trafficking survivors, law enforcement, and advocacy groups.

Letters of Support

TSEC delivered 75+ letters of endorsement from key stakeholders, including survivor advocacy organizations and law enforcement agencies.

FREEDOM REQUIRES ACTION WEBINAR SERIES

The Freedom Requires Action webinar series is the cornerstone of TSEC's education and outreach efforts, engaging diverse audiences on pressing policy issues.

Webinars Hosted:

12 sessions covering topics such as criminal record relief, the intersection of trafficking and technology, and strategies for state-level legislative advocacy.

Audience Impact:

Reached over 1,500 attendees, including legislators, advocacy groups, and the general public to drive widespread awareness and support.

LEGISLATIVE ADVOCACY

TSEC mobilized support for the **Trafficking Survivors Relief Act (TSRA)**, a bipartisan bill advocating for criminal record relief for trafficking survivors at the federal level. TSEC facilitated 50+ letters of endorsement and coordinated with 15 Congressional offices to push the bill forward.

In support of **California Senate Bill 1414**, TSEC played a pivotal role in advocating for increased penalties for buyers of sex with minors, organizing survivor endorsements, and developing a communications toolkit to engage key stakeholders.

TSEC and other advocacy groups partnered in advancing the **Kids Online Safety Act (KOSA)** through committee, amplifying public awareness of the risks posed by many online platforms in human trafficking cases.

Law Enforcement Participation:

Along with multiple other webinars, over 100 law enforcement officials attended the webinar on the Trafficking Survivor Relief Act, building crucial support for the bill among a significant stakeholder group.

SHP AWARDED A GRANT FOR ENHANCED COLLABORATIVE MODEL FOR FREDERICK COUNTY, MARYLAND

In 2024, Safe House Project reached a significant milestone by being named a key partner in the Frederick County Enhanced Collaborative Model (ECM) Task Force to combat human trafficking. Supported by a \$1.06 million grant from the U.S. Department of Justice's Office for Victims of Crime, this initiative represents a groundbreaking step in the fight against trafficking and a testament to Safe House Project's leadership in survivor-centered care and anti-trafficking collaboration.

KEY HIGHLIGHTS OF THE ECM TASK FORCE

Federal Funding:

\$1.06 million over three years to support coordinated efforts against human trafficking in Frederick County, Maryland.

Community Impact:

The task force focuses on identifying and supporting survivors, preventing trafficking, and prosecuting offenders, setting a precedent for statewide and national collaboration.

Survivor-Centered Care:

Safe House Project serves as the primary provider of survivor services, ensuring access to safe housing, legal advocacy, trauma-informed care, and long-term support.

Collaborative Partnerships:

Includes law enforcement agencies, non-profits, and federal partners, showcasing a united approach to combating trafficking.

This milestone underscores Safe House Project's growing capacity to lead transformative anti-trafficking efforts, leveraging innovative partnerships to protect survivors and prevent trafficking. The ECM Task Force serves as a model for how federal, state, and local agencies can work together to create meaningful change in vulnerable communities.

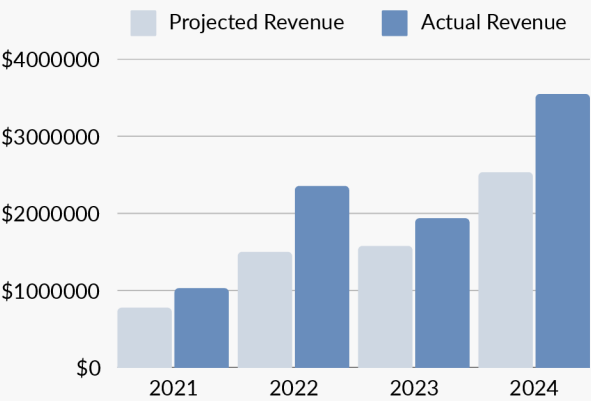

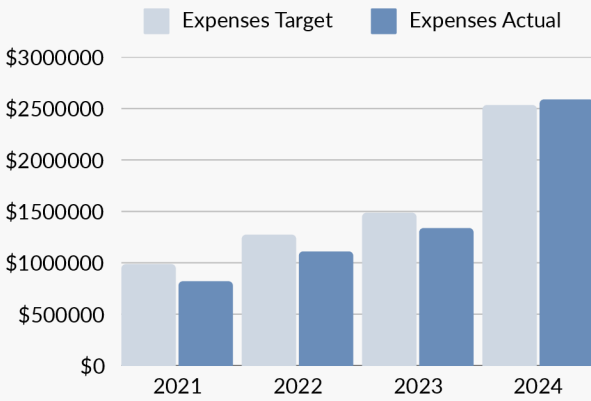
FINANCIAL PERFORMANCE

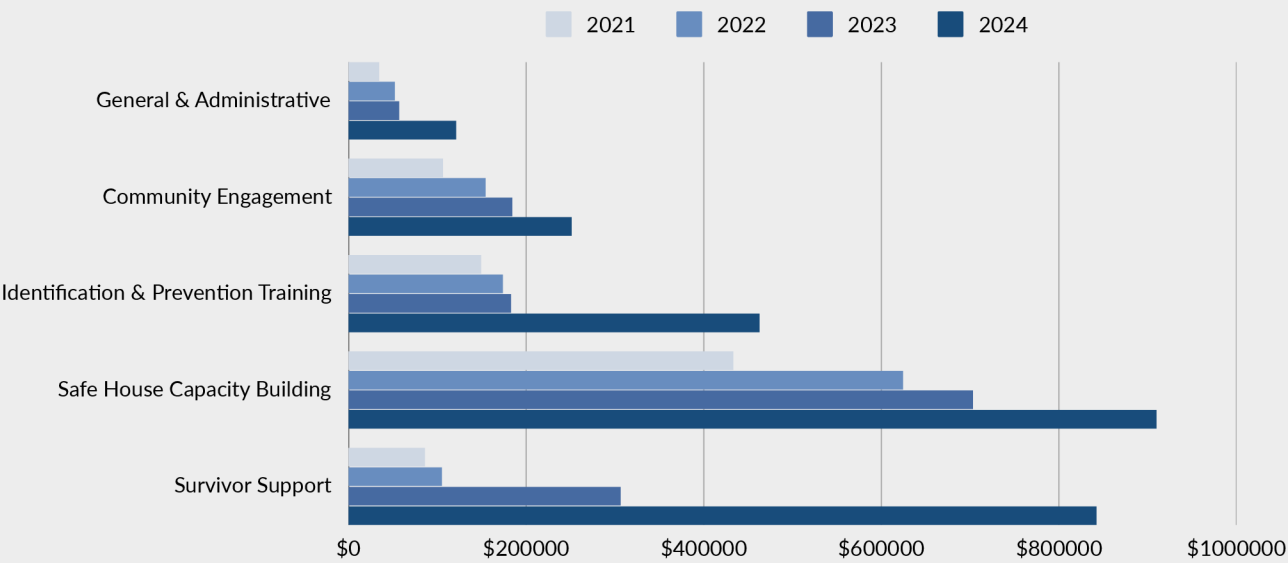
REVENUE TARGETS

YEAR-OVER-YEAR EXPENSES





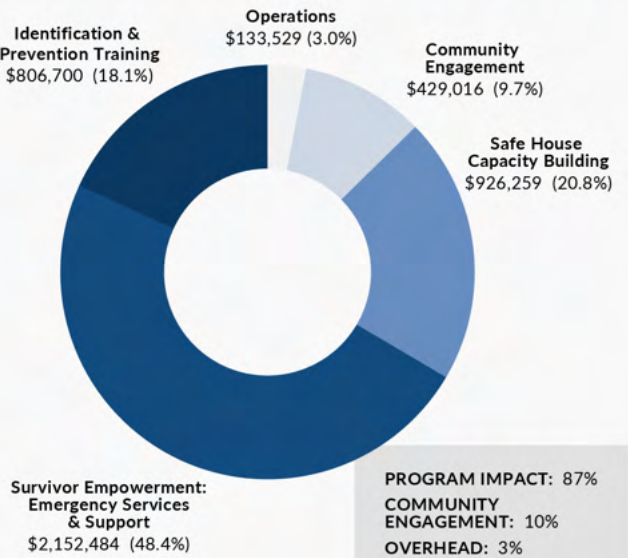
STRATEGIC GROWTH

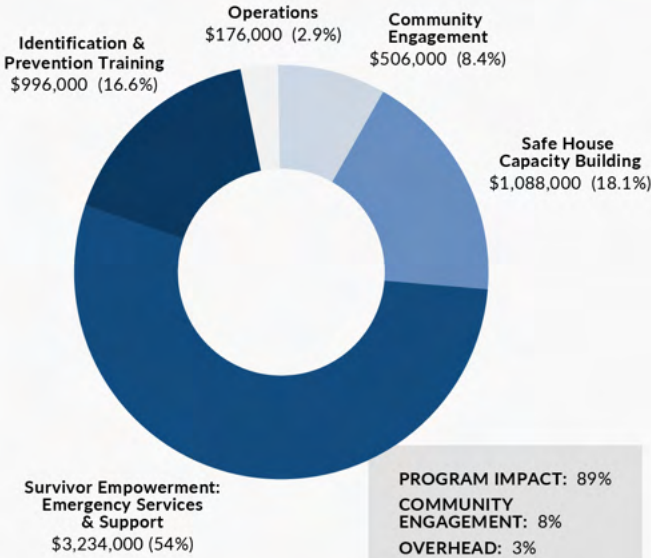
OUR 2025 GOALS

- Serve 2,500 trafficking survivors as they leave exploitation and seek restorative care services.
- Increase the national capacity of safe house programs by an additional 100 beds.
- Certify 50 safe house programs across the United States to provide high-quality care to trafficking survivors.
- Provide development and technical support for 100 safe house programs to elevate their care to meet the highest standards.
- Partner with lawmakers to advance human trafficking legislation in three states.
- Deploy training solutions to see 200,000 people trained to identify and respond to trafficking.

IN THE COMMUNITY



Partnering with our communities is central to Safe House Project's mission to eradicate human trafficking. 
